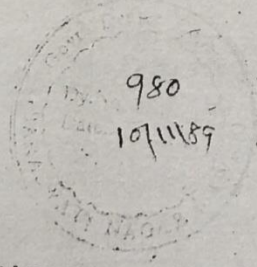

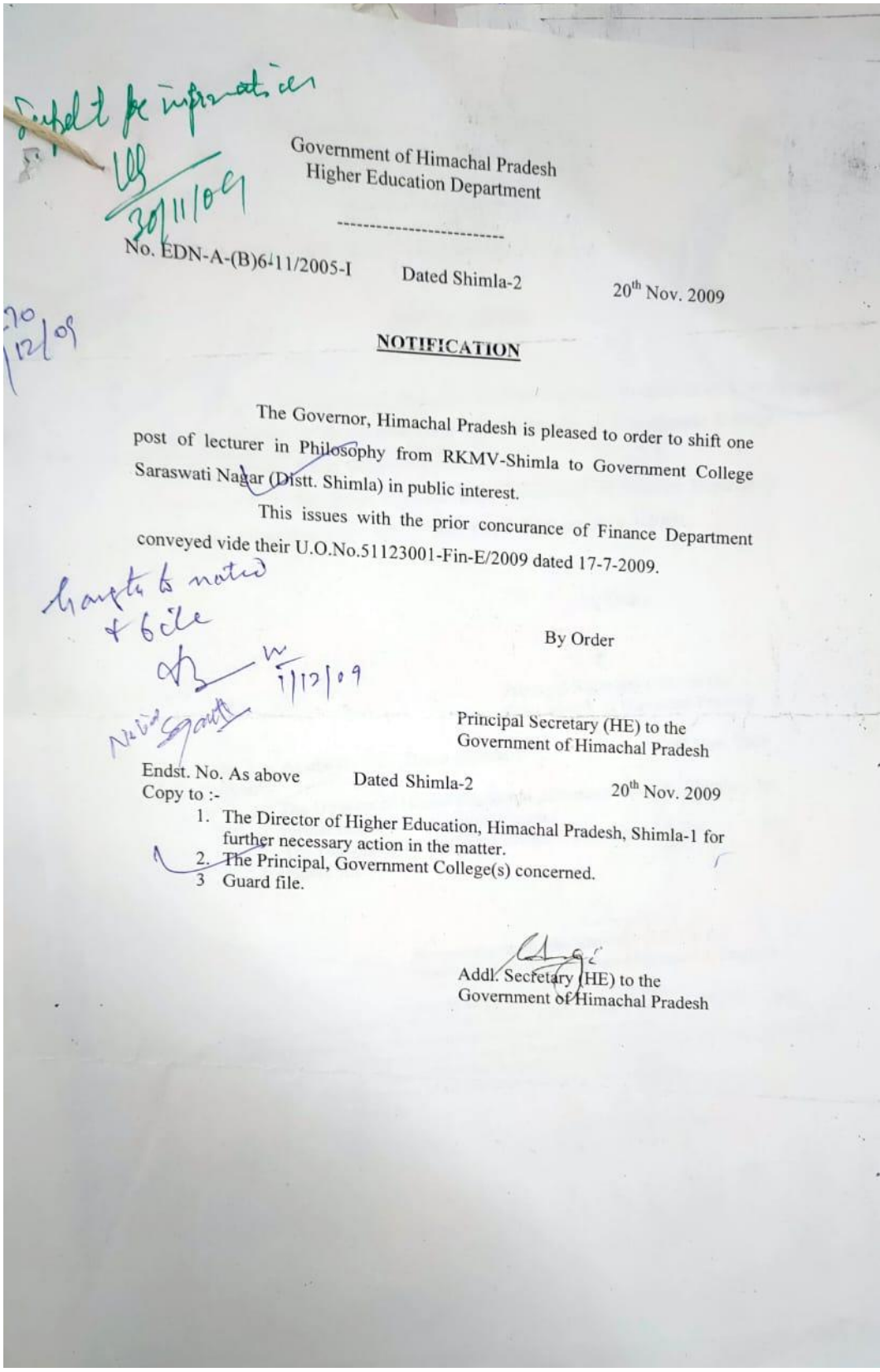


Subject: Compliance of CBCS regulations.



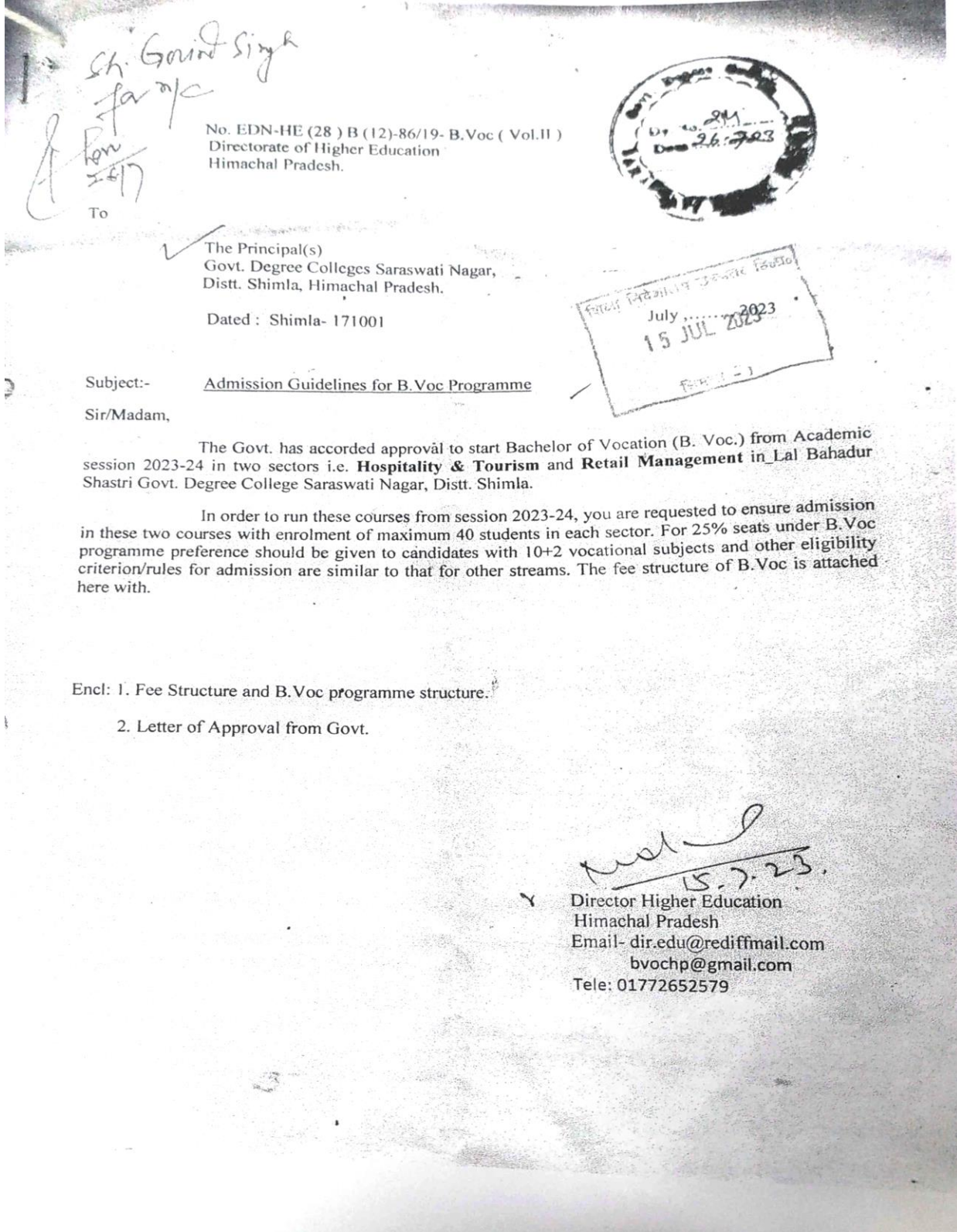

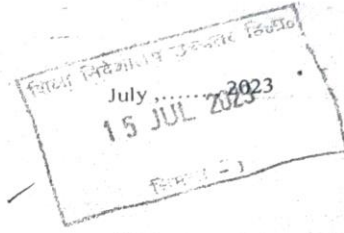
